

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Tompkins Trust Company, a New York bank and trust company having an address at 110 North Tioga Street, Ithaca New York 14850 (“Lender”), does hereby certify that the continuing security interest it holds in the Grantor’s (as defined herein) right, title and interest in, to and under that certain Trademark Collateral of Incodema, LLC, a New York limited liability company formerly known as Incodema, Inc., having an address at 407 Cliff Street, Ithaca, New York 14850 (“Grantor”), granted to Lender pursuant to the Trademark Security Agreement, dated April 30, 2018, by and among Grantor and Lender, which was recorded in the United States Patent and Trademark Office on May 8, 2018, at Reel 6327, Frame 0870 (the “Trademark Security Agreement”; all capitalized terms used herein and not otherwise defined shall have the meanings ascribed to such terms in the Trademark Security Agreement), including the Trademark Collateral identified on Exhibit A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, is hereby released, relinquished and discharged with respect to Grantor and all right, title and interest in such Trademark Collateral previously assigned to Lender under the Trademark Security Agreement is hereby reassigned to Grantor, without representation or warranty of any kind, nature or description. Lender hereby authorizes the Grantor, or the Grantor’s authorized representatives to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. Lender agrees to execute and deliver to the Grantor, at the Grantor’s expense, all other instruments and other documents as may be reasonably necessary or proper to release the security interest in the Trademark Collateral which had been granted under the Trademark Security Agreement.
