## TRADEMARK ASSIGNMENT

1. Assignor hereby assigns to Assignee all of Assignor's right, title, and interest in and to the Marks, together with all of Assignor's right, title, and interest in and to the goodwill and common law rights associated therewith.

2. Assignor and Assignee agree to execute and deliver, at the request of Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all right, title, and interest in and to the Marks to Assignee and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment, to the extent such evidence is in the possession or control of Assignor.

IN WITNESS WHEREOF, the parties have caused this instrument to be executed by their respective duly authorized corporate officers as of the Effective Date.


