(hereinafter referred to as the “REACTEX Trademark”);




ASSIGNOR hereby authorizes **ASSIGNEE**, at the expense of **ASSIGNEE**, to take all necessary and/or appropriate steps to effectuate this Agreement and the transfer of rights hereunder, including recordation thereof in the appropriate Trademark Offices.

ASSIGNOR hereby covenants and agrees that, at any time and from time to time after the Effective Date, at **ASSIGNEE**’s request, or at the request of **ASSIGNEE**’s successors, representatives or assigns, **ASSIGNOR** shall reasonably cooperate with **ASSIGNEE** to execute and deliver such documents and other papers, and otherwise provide reasonable assistance to **ASSIGNEE**, as may be required to grant, transfer, convey, deliver and assign to **ASSIGNEE** any of the REACTEX Trademark.
