PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "*Partial Release*") is granted as of July 13, 2020 by **GORDON BROTHERS COMMERCIAL AND INDUSTRIAL, LLC**, a Delaware limited liability company (the "*Grantee*"), in favor of **AMERICAN SPORTING GOODS CORPORATION**, a Delaware corporation (the "*Grantor*");

WHEREAS, the Grantor has executed and delivered a Trademark Security Agreement, dated as of May 14, 2013 (the "*Agreement*"), which was recorded with the United States Patent and Trademark Office (the "*PTO*") on May 24, 2013, at Reel 005035 and Frame 0001;

WHEREAS, the Grantor has entered into that certain Asset Purchase Agreement, dated as of June 22, 2020 (the "*Purchase Agreement*"), with the Grantor as the seller and Nevados IP LLC, a New York limited liability company (the "*Assignee*"), pursuant to which, the Grantor has agreed to assign to the Assignee all of its right, title and interest in the Trademarks (as defined in the Agreement) set forth in Schedule A annexed hereto (the "*Released Trademarks*"); and

WHEREAS, in connection with the Purchase Agreement, the Grantor has requested that the Grantee release and discharge fully its interest in the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantee does hereby release and discharge, without any representation or warranty, any and all liens and security interests it may have in and to the Released Trademarks expressly identified in Schedule A.

The Grantee hereby authorizes and requests that the PTO note and record the present Partial Release.

Except for the release of the Released Trademarks specifically identified on Schedule A attached hereto, all terms and provisions of the Agreement shall remain in full force and effect. Nothing contained herein shall in any way impair the validity or enforceability of the Agreement, as modified hereby, or alter, waive, annul, vary, affect, or impair any provisions, conditions, or covenants contained therein or any rights, powers, or remedies granted therein. **Any lien and/or security interest granted in any Trademark pursuant to the Agreement shall remain unchanged and in full force and effect except as specifically released hereby.**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
