SECURITY INTEREST IN TRADEMARKS**

WHEREAS, pursuant to the Security Agreements, the Grantor granted to the Security Party a lien on all of the Grantor's right, title and interest in and to the registered Trademarks set forth on Schedule A attached hereto and made a part hereof (the "Trademarks"); and

WHEREAS, the Secured Party has agreed to release, relinquish, terminate and discharge its right, title and interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

1. The Secured Party hereby releases, relinquishes, terminates and discharges in its entirety any and all lien or security interest it has in the Trademarks. All rights, title and interest in and to such Trademarks, including, without limitation, the right to sue for past, present and future infringement, hereby reverts to the Grantor.
2. The Secured Party authorizes and requests the United States Patent and Trademark Office to record this Release against such Trademarks, as applicable.
3. The Secured Party hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purpose of this Release.
