NOW, THEREFORE, Singularity and CSI agree as follows and confirm that:



Singularity has assigned and transferred, and CSI has received and accepted, all of Singularity's rights, title and interest throughout the world in and to the Singularity Marks and all the rights, claims and privileges pertaining to the Singularity Marks, including without limitation: the registrations pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Singularity Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Singularity in all matters related thereto.


Singularity hereby authorizes and requests that the relevant officials of the relevant countries implement this Assignment.
