At any time and from time to time after the date of this Trademark Assignment, upon the request of PlanetArt, Avanquest shall execute, acknowledge and deliver any and all further assurances, assignments, transfers, conveyances, powers of attorney, and other instruments and documents, and take such other actions deemed by PlanetArt, in good faith, to be necessary or appropriate to effectuate or document the assignment to PlanetArt confirmed herein.
