RELEASE OF SECURITY INTEREST IN TRADEMARKS

FOR VALUE RECEIVED, the undersigned, **BANK OF AMERICA, N.A.**, a national banking association, as successor in interest to Fleet Capital Corporation, in its capacity as agent for itself and various financial institutions ("**Agent**"), hereby releases and terminates all of its liens and security interests in and to the trademarks and trademark applications listed on Schedule A attached hereto (the "**Trademark Collateral**"), and Agent hereby reassigns all right, title and interest (if any) that Agent may have in the Trademark Collateral to **ROCKLAND INDUSTRIES, INC.**, a Maryland corporation ("**Assignee**"), with a mailing address 4969 Mercantile Road, Suite A, Baltimore, Maryland 21236, as applicable, **without any representation or warranty by, or recourse to**, Agent, arising under that certain (i) Trademark Security Agreement dated January 13, 2000, between Agent (as successor in interest to Fleet Capital Corporation) and Assignee, as recorded in the United States Patent and Trademark Office on January 19, 2000, at Reel No. 002019, Frame 0095 (the "**Original Security Agreement**"), assigned to Agent pursuant to that certain Assignment of Trademark Security Agreement effective August 1, 2005, by Banc of America Leasing & Capital, LLC (successor to Fleet Capital Corporation) to Bank of America, N.A., a national banking association, as recorded in the United States Patent and Trademark Office on March 29, 2007, at Reel No. 3511, Frame 0268; and (ii) Letter Amendment to Trademark Security Agreement dated February 22, 2007, recorded in the United States Patent and Trademark Office on March 29, 2007 at Reel No. 003511, Frame 0001 (the "**Amendment**"); together with the Original Security Agreement, the "**Trademark Security Agreement**") together with the goodwill of the business symbolized by the Trademark Collateral.

This Release of Security Interest in Trademarks (this "**Release**") is intended to operate as a release of all liens and security interests conveyed by Assignee to Agent pursuant to the terms of the Trademark Security Agreement, and to reassign to Assignee all of Agent's right, title, and interest acquired pursuant to the terms of such Trademark Security Agreement.
