RELEASE OF TRADEMARK COLLATERAL

This RELEASE OF TRADEMARK COLLATERAL (“Release”) dated as of August 17, 2020, is made by MONROE CAPITAL MANAGEMENT ADVISORS, LLC, as administrative agent for the Lenders (the “Administrative Agent”) in favor of the Grantors listed on Schedule A hereto (the “Grantors”). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Credit Agreement (as defined below) or the Trademark Security Agreement (as defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Credit Agreement dated as of October 18, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), the applicable Grantors executed a Trademark Security Agreement dated as of October 18, 2019, recorded with the United States Patent and Trademark Office on January 21, 2019 at Reel 6775, Frame 0400 (the “Trademark Security Agreement”), pursuant to which such Grantors granted a continuing security interest to the Administrative Agent, for the benefit of the Lenders, in the applicable Trademark Collateral.

WHEREAS, the Administrative Agent now desires to terminate and release its security interest in certain trademark registrations and applications of the Trademark Collateral while maintaining its security interest in other trademark registrations and applications of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent, for itself and for the benefit of the Secured Parties, hereby irrevocably discharges, terminates and releases its Lien on and security interest in all of the applicable Grantors’ right, title and interest in and to the trademarks set forth on Schedule A (the “Released Trademark Collateral”).

2. The Administrative Agent authorizes and requests that the Commissioner of the United States Patent and Trademark Office and any other applicable government authority record this Release.

3. This Release and the rights and obligations of the parties hereto shall be governed by and construed and interpreted in accordance with the laws of the State of New York and shall be binding upon the parties’ representatives, successors, assigns and transferees.
