

RELEASE OF SECURITY INTEREST IN TRADEMARKS

If and to the extent that the Administrative Agent has acquired any right, title or interest in and to the trademark collateral under the Trademark Security Agreements, the Administrative Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantors.
- 3. <u>Termination</u>. The Administrative Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.
- 4. <u>Governing Law</u>. This Release shall be governed exclusively under the laws of the Commonwealth of Pennsylvania, without regard to conflicts of law or choice of law principles.
