**AMENDED AND RESTATED GRANT OF SECURITY INTEREST IN TRADEMARKS**  
**(SECOND LIEN)**

This AMENDED AND RESTATED GRANT OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN) dated July 31, 2020, is made by and between NatWest Markets plc ("Outgoing Collateral Agent") and Lucid Trustee Services Limited ("New Collateral Agent"), and acknowledged and agreed to by Datix (USA) Inc. ("Grantor").

WHEREAS, pursuant to the Security and Pledge Agreement (Second Lien) dated June 26, 2018 ("Second Lien Security Agreement"), Grantor granted a continuing security interest in and continuing lien on the PAVISSE trademark (U.S. Registration No. 4602191) to the Outgoing Collateral Agent for the ratable benefit of the Secured Parties (as defined in the Second Lien Security Agreement);

WHEREAS, Grantor and the Outgoing Collateral Agent recorded the Notice of Grant of Security Interest in Trademarks with the U.S. Patent and Trademark Office at Reel 6397 / Frame 0897 to provide notice of the Second Lien Security Interest (the "Original Notice Filing"); and

WHEREAS, pursuant to a Substitution and Transfer Deed (the "Substitution Deed") dated July 31, 2020, the New Collateral Agent shall replace the Outgoing Collateral Agent and the New Collateral Agent shall be the "Collateral Agent" (as defined in the Second Lien Security Agreement) in place of the Outgoing Collateral Agent for all purposes under and pursuant to the Second Lien Security Agreement.

NOW THEREFORE, in consideration of the mutual promises and obligations set forth in the Substitution Deed, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and accepted, each of Outgoing Collateral Agent, New Collateral Agent, and Grantor agrees as follows:

1. The Notice of Grant of Security Interest of Trademarks recorded with the U.S. Patent and Trademark Office at Reel 6397 / Frame 0897 is hereby amended and restated to replace all references to the Outgoing Collateral Agent with the New Collateral Agent.
2. As set forth in Section 2 of the Substitution Deed, the Outgoing Collateral Agent shall be discharged from any further obligation in respect of the Second Lien Security Agreement.
3. Except as set forth above in paragraphs 1 and 2, the terms of the Original Notice Filing remain in full force and effect and are incorporated by reference herein as if fully set forth herein.


