RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”) is made as of August 12, 2020 (“Effective Date”) by GOLUB CAPITAL LLC, a Delaware limited liability company, in its capacity as Administrative Agent (the “Agent”) for the Lenders, in favor of PURFOODS, LLC, an Iowa limited liability company (“Borrower”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit Agreement (as defined below).

W I T N E S S E T H

WHEREAS, pursuant to that certain Security Agreement, dated as May 2, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), among the Borrower, the other Loan Parties thereto and the Agent, Borrower has granted to Agent, for its benefit and the benefit of the Lenders, a security interest and lien upon substantially all assets of Grantor (as defined below), including all right, title and interest of Borrower in, to and under all now owned and hereafter acquired Trademarks (including registrations and applications thereof, and all applications in connection therewith), together with the goodwill of the business symbolized by Grantor’s Trademarks, and all proceeds thereof, to secure the payment of all amounts owing by Borrower pursuant to the terms and conditions set forth in the Credit Agreement, dated as of May 2, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) among the Borrower, Agent, the Lenders, and the other Loan Parties thereto.

WHEREAS, pursuant to the Security Agreement, that certain Trademark Security Agreement, dated as of May 2, 2016, was made by the Borrower as grantor (the “Grantor”) and the Agent as grantee (the “Trademark Security Agreement”), to record the security interest with respect to the Trademark Collateral (as defined in the Trademark Security Agreement) of Grantor, including those items set forth on Schedule A hereto, and was recorded with the Trademark Division of the United States Patent and Trademark Office on May 3, 2016 as Reel 5784 and Frame 0161; and

WHEREAS, Grantor has satisfied the terms of the Security Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral.

NOW, THEREFORE, pursuant to the terms of that certain payoff letter, dated as of the date hereof, by and among, the Agent, the Borrower and other parties thereto, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, on behalf of itself and the Lenders, without recourse, representation, warranty or other assurance of any kind by the Agent, (i) terminates the Trademark Security Agreement and releases, discharges and cancels and re-assigns to Grantor any and all liens, security interests, right, title and interest it may have in, to and under any and all Trademark Collateral, including those items set forth on Schedule A hereto, together with the goodwill of the business symbolized thereby; and (ii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the

release and termination of the Agent's rights under the Security Agreement with respect to the Trademark Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.



