PARTIAL TRADEMARK ASSIGNMENT

The Assignor also assigns and transfers to the Assignee any and all rights to sue for past, present or future infringement(s) of the Partial Interest as well as any and all rights to collect damages or compensation for such acts of past, present or future infringement of the Partial Interest. Assignee accepts the transfer of all right, title, and interest in and to the Partial Interest.

The Assignor retains all right, title, and interest in and to the Retained Interest (identified in Attachment C) in and to the Mark and Registration, together with the goodwill of the business symbolized by and associated with the Retained Interest, and all common law and registered trademark rights associated with the Retained Interest. The Assignor also retains any and all rights to sue for past, present or future infringement(s) of the Retained Interest as well as any and all rights to collect damages or compensation for such acts of past, present or future infringement of the Retained Interest.

This Assignment shall be binding upon the Assignor and Assignee's heirs and legal representatives.

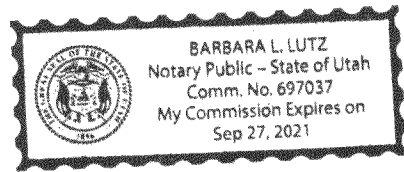

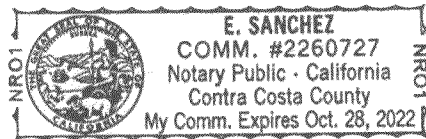
