As part of this Assignment, ASSIGNOR further agrees to transfer, and hereby transfers all tangible and intangible assets of the business of ASSIGNOR related to the Marks including graphics, digital files, websites, domains, etc. to ASSIGNEE.

ASSIGNOR further covenants and agrees to execute all documents, papers, forms, authorizations, and/or other actions that may be necessary for ASSIGNEE to secure, complete, record, and/or perfect the transfer of rights in the Marks for this Assignment, including any pending



applications for the Marks. ASSIGNOR also covenants and agrees to cease all use of the Marks upon execution of this Assignment.

In the event that assignment of one or more of the Marks under this Assignment is ineffective, by operation of law or otherwise, ASSIGNOR hereby grants ASSIGNEE an exclusive, irrevocable, worldwide, royalty-free license to fully use the Marks whose assignments were ineffective.


Section III – Miscellaneous
