ASSIGNMENT OF PATENT AND TRADEMARK SECURITY AGREEMENTS

WHEREAS, pursuant to that certain Successor Agent Agreement, dated as of July 3, 2020, by and among Resigning Agent, Successor Agent and the other parties party thereto, Resigning Agent has assigned to Successor Agent all of its rights, powers, privileges and duties under, among other documents, the Agreements and the Subject IP, in each instance, in its capacity as administrative agent under the Credit Agreement.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Resigning Agent hereby assigns and transfers to Successor Agent and its successors and assigns, all of its rights, powers, privileges and duties in and to the Agreements.


