2 Assignment

Subject to and with effect from the Date of Assignment, the Assignor assigns to the Assignee free from encumbrance and in exchange for good and valuable consideration:

(a) all property, right, title and interest (both legal and beneficial) in the Trade Mark;

- (b) all associated common law rights and the goodwill arising from use of the Trade Mark; and
- (c) the right to sue for and recover damages and other relief in relation to any infringement of the Trade Mark, including any infringement that may have occurred before the Date of Assignment.

3 Assignors obligations

The Assignor will execute all documents, forms and authorisations, as may be required to enable registration of the Trade Mark in the name of the Assignee.

4 Assignee's obligations

On and from the Date of Assignment, the Assignee is solely responsible for maintenance of the Trade Mark in its sole discretion.

5 Payment of consideration

The Assignor acknowledges that it has received good and valuable consideration from the Assignee for the assignment of the Trade Mark.




