## IP Assignment Agreement

Relating to the transfer of Real Pet Food  
Company Intellectual Property

THIS AGREEMENT is made on

18 June

2019

**BETWEEN:**

- (1) **RPF CBidco Pty Limited** ACN 621 969 855 whose registered office is 39-47 Albany Street, Crows Nest, New South Wales 2065 (the **Assignee**); and
- (2) The companies set out in Annexure A (the **Assignors**).

**RECITALS:**

- (A) The parties, among others, have entered into an Asset Sale Agreement dated [on or about the date of this document (**Main Agreement**)].
- (B) The Assignors are the owners of the Business IP.
- (C) Under the Main Agreement, the Assignors are required to assign the Business IP to the Assignee.
- (D) The Assignors agree to assign the Business IP to the Assignee on the terms of this document.

**THE PARTIES AGREE AS FOLLOWS:**

1. **INTERPRETATION**

1.1 **Definitions**

The following definitions apply in this document.

**Business IP** means the Intellectual Property set out in Annexure B and Intellectual Property registered or filed for registration on an IP Register by an Assignor after the date of this document, provided that the Assignor notifies the Assignee of the details of the Intellectual Property. For the avoidance of doubt, excludes any Intellectual Property owned by an Assignor that is not set out in Annexure B or notified to the Assignee by the Assignor after the date of this document.

**Conditions Precedent** means the conditions set out in clauses 3.1(a) and 3.1(b) of the Main Agreement.

**Effective Date** means the date of 'First Completion' under the Main Agreement.

**Intellectual Property** means all present and future rights conferred by law in or in relation to copyright, trade marks, trade names, brand names, product names or logos, designs, patents, circuit layouts, plant varieties, domain and business names, inventions and confidential information, and other results of intellectual activity in the industrial, commercial, scientific, literary or artistic fields whether or not registrable or patentable, registered or unregistered.

These rights include:

- (a) all rights in all applications to register these rights;
- (b) all renewals and extensions of these rights; and
- (c) all rights in the nature of these rights, excluding Moral Rights.

**IP Registers** means the public registers anywhere in the world recording registered Intellectual Property.

**Main Agreement** means the Asset Sale Agreement between the parties, among others, as described in Recital A.

**Registered IP** means the Business IP recorded in the name of any of the Assignors on the IP Registers at the Effective Date and/or the Business IP in respect of which the Assignor has a right to such recordal as at the Effective Date.

1.2 **Inconsistency**

If a provision of this document is inconsistent with a provision of the Main Agreement, the provision in the Main Agreement prevails.

2. **CONDITIONALITY**

Clauses 3 and 4 of this document will have no force and effect until such time as the Conditions Precedent have been satisfied or waived in accordance with the terms of the Main Agreement.

3. **ASSIGNMENT**

With effect from the Effective Date, each Assignor, as legal and beneficial owner, assigns to the Assignee (or the Assignee's nominee) absolutely all its right, title and interest subsisting in and to the Business IP with effect from the Effective Date and, including:

- (a) in respect of any Registered IP, all rights for the remainder of the term of those rights, including all renewals and extensions in the jurisdiction specified in Annexure B;
- (b) any common law rights;
- (c) the right to be registered or recorded as the owner of the Registered IP on IP Registers;
- (d) the right to sue for, and recover, damages and other relief in relation to any infringement of any of the rights assigned by this document (including for conversion or detention) including any that may have occurred before the Effective Date; and
- (e) the right to claim Paris Convention priority for any Trade Mark set out in Annexure B if applicable.

4. **FURTHER ASSURANCES**

- (a) Each party agrees, at its own expense, to do anything reasonably requested by another party (such as signing and producing documents) as may be necessary or desirable to enable the Assignee to become registered as the owner of the Business IP as applicable.
- (b) Without limiting clause 4(a), each Assignor must, at its cost:
  - (i) ensure that a copy of all documents concerning the Registered IP held by the Assignor are delivered to the Assignee or its nominee within 20 days of the Effective Date; and
  - (ii) use reasonable endeavours to procure that a copy of all documents concerning the Registered IP held by the Assignor's solicitors, attorneys or agents are (if reasonably required) made available to the Assignee upon 48 hours written notice being provided by the Assignee or its nominee.

5. **GENERAL**

5.1 **Counterparts**


- (a) This document may be executed in counterparts.
- (b) Delivery of a counterpart of this document by email attachment (pdf) constitutes an effective mode of delivery.

5.2 **Governing law**

- (a) This document and any dispute arising out of or in connection with the subject matter of this document is governed by the laws of the State of New South Wales.
- (b) Each party submits to the exclusive jurisdiction of the courts of that State and courts of appeal from them, in respect of any proceedings arising out of or in connection with the subject matter of this document.






