- (c) the rights of Assignor in and to the applications for and registrations of said trademarks specified on the attached Exhibit B.



Assignor disclaims any and all representation, warranty, responsibility or liability, explicitly or implied, with respect to filing, application, registration and assignment of said trademarks, and such trademarks shall be treated the same as other marks created or registered by Assignee.


