THIRD: The name of the surviving corporation is Brink's, Incorporated.

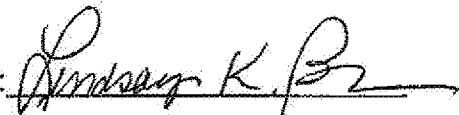
FOURTH: The merger is to become effective on January 2, 2020.
