**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY dated as of August 18, 2020 (this "Release"), is made by COMERICA BANK (in such capacity, the "Secured Party"), in favor of NEW SIGNATURE US, INC. (formerly CHH Enterprises, Inc. and InfraScience, LLC), a Maryland corporation ("Debtor"). Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Debtor and the Secured Party entered into that certain Intellectual Property Security Agreement, dated as of March 1, 2016 (the "Security Agreement"), pursuant to which the Debtor granted to the Secured a security interest in and to all of their right, title and interest in, to and under the Intellectual Property Collateral owned by the Debtor including, without limitation, those Copyrights, Patents and Trademarks listed on Schedule A, B and C attached hereto;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on March 11, 2016 at Reel 005750 and Frame 0149; and

WHEREAS, the Debtor has requested and the Secured Party has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and to the Intellectual Property Collateral.


NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interests created under the Security Agreement in the Intellectual Property Collateral, (b) discharge and release its security interest in and to the Intellectual Property Collateral, and (c) reassign any and all rights, title and interest it has in the Intellectual Property Collateral to the Debtor.

THIS RELEASE SHALL BE DEEMED TO BE A CONTRACT UNDER THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO ITS CONFLICT OF LAWS PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF ANY OTHER LAW.
