WHEREAS, Assignee desires to acquire the Marks, and any and all U.S. and international applications and registrations therefor, together with the goodwill associated therewith.


NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:
