3 The Merged Company has its principal office in Montgomery County, Maryland, and the Surviving Company has its principal office in Montgomery County, Maryland Neither the Merged Company nor the Surviving Company owns an interest in land in the State of Maryland

4 The Articles of Merger were duly advised, authorized and approved by the sole member of the Merged Company by written consent in lieu of a meeting as of December 22, 2016

5 The Articles of Merger were duly advised, authorized and approved by the sole member of the Surviving Company by written consent in lieu of a meeting as of December 22, 2016

6 The Merged Company has a single class of membership interest which is 100% owned by the existing sole member

7 The Surviving Company has a single class of membership interest which is 100% owned by the existing sole member

8 All outstanding membership interests of the Merged Company will automatically be cancelled and retired and will cease to exist, and no consideration will be delivered in exchange therefor All membership interests of the Surviving Company shall remain outstanding following the consummation of this merger




