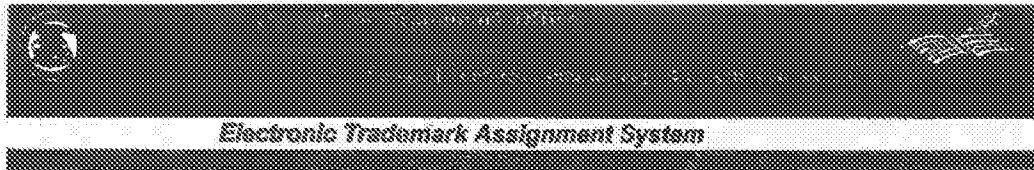

TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment"), dated as of March 31, 2020 (the "Effective Date"), is made and entered into by and between Kellytoy Worldwide, Inc., a California corporation ("KWI"), Kellytoy (USA), Inc., a California corporation ("KUI", and together with KWI, each, a "Transferor" and together, the "Transferors"), Kelly Toy Holdings, LLC, a Delaware limited liability company ("Toys LLC") and Kelly Amusement Holdings, LLC, a Delaware limited liability company ("Amusement LLC" and, collectively with Toys LLC, the "Transferees"), (each a "Party" and collectively, the "Parties"). Capitalized terms used herein without definition shall have the respective meanings set forth in the Purchase Agreement (as defined below).

RECITALS:

WHEREAS, Transferors are affiliated entities that own certain assets relating to the toy and amusement industries business (the "Business");

WHEREAS, the Transferors have entered into a Securities Purchase Agreement, dated as of March 9, 2020 (the "Purchase Agreement"), by and among Jazwares, LLC and certain of its affiliates (collectively, the "Buyer Group") and other persons named in the Purchase Agreement, pursuant to which the Transferors will sell to certain members of the Buyer Group, and those members will purchase from the Transferors, seventy-five percent (75%) of the issued and outstanding membership interests in each of the Transferees;

WHEREAS, (i) KWI is the owner of all right, title, and interest in and to the Trademarks and the accompanying registrations and applications set forth in Schedule 1 and Schedule 2 attached hereto, (ii) KUI is the owner of all right, title, and interest in and to the Trademarks and the accompanying registrations and applications set forth in Schedule 3 attached hereto, (iii) Toys LLC desires to acquire all right, title, and interest in and to the Trademarks and the accompanying registrations and applications set forth in Schedule 1 and Schedule 3 (the "Toys Trademarks") and (iv) Amusement LLC desires to acquire all right, title, and interest in and to the Trademarks and the accompanying registrations and applications set forth in Schedule 2 attached hereto (the "Amusement Trademarks");

WHEREAS, in connection with the Purchase Agreement, Transferors and Transferees have entered into a Contribution Agreement (the "Contribution Agreement"), whereby Transferors contributed substantially all of Transferors' assets to Transferees in accordance with the terms and conditions of the Contribution Agreement; and

WHEREAS, pursuant to the terms of the Contribution Agreement, each Transferor has agreed to convey, transfer and assign to Transferees the Toys Trademarks and the Amusement Trademarks owned by such Transferor, together with the goodwill of the Business symbolized thereby (the "Assigned Trademarks"), and has agreed to execute and deliver this Assignment to enable recording of the conveyance with the appropriate Governmental Authority including, but not limited to, the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the foregoing and the mutual agreements, provisions and covenants contained in this Assignment, the Parties, intending to be legally bound, hereby agree as follows:

1. Assignment. Each Transferor hereby irrevocably sells, assigns, grants, conveys, transfers, and sets over unto the applicable Transferee set forth on Schedules 1, 2, and 3, all of such Transferors' respective rights, title and interest in and to the Assigned Trademarks, together with all national, foreign, state and common law rights, registrations or applications, renewals or extensions thereof or applications for such; all goodwill associated therewith, all benefits, privileges, causes of action and remedies relating to any of the foregoing, whether before or hereafter accrued including, without limitation, the exclusive rights to apply for and maintain all such registrations, renewals and/or extensions; to sue for all past, present or future infringements or other violations of any rights in the Assigned Trademarks; and to settle and retain proceeds from any such actions, except to the extent arising out of, or related to, any of the Excluded Assets as defined in the Contribution Agreement, whether arising by way of counterclaim or otherwise.

2. Recordation and Further Actions. Transferees shall be solely responsible for all actions whatsoever, including but not limited to, payment of Taxes, attorneys' fees and trademark office fees in any jurisdiction associated with the perfection of Transferees' right, title, and interest in and to the Assigned Trademarks and recordation and/or registration of this Assignment or any other document evidencing the assignment to Transferees of the Assigned Trademarks. Transferors hereby authorize the Commissioner for Trademarks in the United States Patent and Trademark Office, and the corresponding Governmental Authority in any applicable foreign countries or multinational authorities, to record Transferees as the assignee and owner of the Assigned Trademarks. Following the date hereof, Transferors shall execute and deliver such documents, files, registrations, or other similar items as Transferees may reasonably request to effectuate the assignment of the Assigned Trademarks to Transferees, or any assignee or successor thereto.

3. No Conflict. In the event of a conflict between the terms and conditions of this Assignment and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall govern, supersede and prevail. Notwithstanding anything to the contrary, nothing herein is intended to, nor shall it, extend, amplify or otherwise alter the representations, warranties, covenants or indemnification obligations of the parties contained in the Purchase Agreement.

4. Successors and Assigns. The provisions of this Assignment and the obligations and rights hereunder shall be binding upon, inure to the benefit of and be enforceable by (and against) the Parties and their respective successors and permitted transferees and assigns.

5. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

6. Title and Headings. Titles and headings to sections herein are inserted for the convenience of reference only and are not intended to be a part of or to affect the meaning or interpretation of this Assignment.

7. Governing Law. This Assignment and any claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).


8. Amendment. None of the provisions of this Assignment may be waived, changed or altered except in a signed writing by the party against whom enforcement of the same is being sought.




