

TRADEMARK ASSIGNMENT

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

- 1. Assignor hereby irrevocably sells, assigns, transfers, convey and sets over to Assignee, its successors and assigns all of Assignor's rights, title and interest in and the Trademarks, including any common law rights and the to: (a) each of registrations and applications thereof, together with the goodwill of the businesses symbolized by the Trademarks being assigned; (b) all internet domain name registrations and social media account or user names (including "handles" incorporating any Trademark, and all associated web addresses, URLs, websites and web pages, and social media sites and pages, and all content and data thereon or relating thereto; (c) all licenses and similar contractual rights or permissions, whether exclusive or nonexclusive, related to any of the Trademarks; (d) all royalties, fees, income, payments, and other proceeds now or hereafter due or payable to Assignor with respect to any of the foregoing; (e) all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the Effective Date, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, violation, breach, or default; and (f) all other rights, privileges, and protections of any kind whatsoever of Assignor accruing under any of the foregoing provided by any applicable law, treaty, or other international convention throughout the world.
- 2. Assignor agrees to execute and deliver at the request of Assignee, all papers, documents, instruments and assignments, and to perform any other reasonable acts, that (1) Assignee may require in order to vest all of Assignee's rights, title and interest in and to the Trademarks in Assignee; (2) may be required in states and countries foreign to the United States, to record Assignee as the owner of the

Assignor also agrees to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.

- 3. Assignor further authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any state or country foreign to the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this instrument.
- 4. Each provision of this Agreement shall be considered separable; and if, for any reason, any provision of this Agreement is determined by a court of competent jurisdiction to be invalid, unlawful, or unenforceable, such determination shall not affect the enforceability of the remainder of this Agreement or the validity, lawfulness, or enforceability of such provision in any other jurisdiction.
- 5. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, email, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.
- 6. This Agreement may be amended in a written document signed by each party to be bound by the amendment and that identifies itself as an amendment to this Agreement.
- 7. All matters arising from or relating to this Agreement and the transactions contemplated hereby shall be governed by and construed in accordance with the laws of the State of New York without giving effect to any choice or conflict of law provision or rule. Each party irrevocably and unconditionally submits to the exclusive jurisdiction of The United States District Court for the Southern District of New York, or if such court does not have jurisdiction, New York State Supreme Court in the borough of Manhattan, for purposes of enforcing this Agreement.
