Trademark Assignment

This Trademark Assignment Agreement is between **Henkel Iberica S.A., Henkel Ibérica Operations, S.L.**, both corporations organized and existing under the laws of Spain, having their principal place of business at Calle Bilbao, 72-84, 08005 Barcelona (hereinafter together referred to as "Henkel Iberica" or the "Assignor") and **Henkel IP & Holding GmbH**, a company duly organized and existing under the laws of Germany, having its principal place of business at Henkelstraße 67, 40589 Düsseldorf, Germany (hereinafter referred to as "HIPH" or "Assignee").

Whereas, effective July 3, 2017, **GCP Applied Technologies Inc.** ("GCP") and **Henkel AG & Co. KGaA**, a corporate affiliate of each of the parties hereto ("Henkel"), entered into that certain Amended and Restated Stock and Asset Purchase Agreement (the "SAPA") pursuant to which GCP agreed to convey, and to cause other Seller Entities (as defined in the SAPA) to convey, to Henkel all of the Seller Entities' right, title and interest in and to certain Purchased Assets (as defined in the SAPA), including certain intellectual property assets; and

Whereas, pursuant to the SAPA, GCP assigned such intellectual property assets, as identified by schedule, to HIPH by that certain IP Assignment Agreement effective July 3, 2017 (the "IP Assignment"); and

Whereas, the parties have learned that the schedule to the IP Assignment inadvertently included certain trademark assets previously held by GCP Applied Technologies Iberia, S.L., that, pursuant to the SAPA, were acquired and are currently held by Henkel Iberica, as identified in Schedule A hereto (the "Marks"); and

Whereas, parties wish to correct this error, and to confirm the transfer of the Marks to HIPH, *nunc pro tunc*, for the purposes of filing the same with the appropriate governmental offices.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby transfers, assigns, and delivers to Assignee, and Assignee hereby accepts, effective as of July 3, 2017, all right, title and interest in and to said Marks, together with the goodwill of the business associated therewith, as well as all rights to damages or profits, due or accrued, arising out of past infringement of such service mark or injury to said goodwill and the right to sue for and recover the same in the Assignee's own name.
