TRADEMARK ASSIGNMENT

Assignor does hereby sell, assign, transfer and convey to Assignee, its successors, and assigns, absolutely and forever, (1) Assignor's entire right, title and interest, in and to the Assigned Mark, in the United States and all countries throughout the world, together with the goodwill arising out of or in any way associated with the Assigned Mark, and (2) its entire right to bring actions for the enforcement of the Assigned Mark, including but not limited to, the right to sue for and recover damages for any past and future infringement of the Assigned Mark.

2. At Assignee's reasonable request, Assignor agrees to execute, for no additional consideration, such further documents and do such other acts as may be necessary and proper to vest full title in and to the Assigned Mark in the Assignee or which may be necessary to obtain, renew, issue or enforce the Assigned Mark.

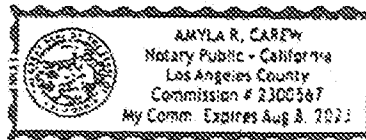

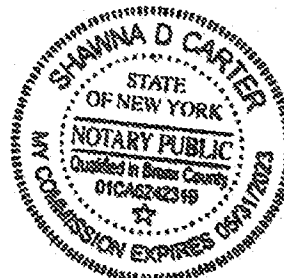
