RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property (this “Release”) is effective as of August 21, 2020, by CIBC BANK USA, formerly known as The Privatebank and Trust Company, as agent for certain secured parties (the “Agent”), in favor of TROJAN LITHOGRAPH CORPORATION, a Washington corporation (the “Grantor”). All terms not herein defined, have the meanings set forth in the Security Agreement referenced below.

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of May 8, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), Grantor granted to the Agent a continuing security interest in and continuing lien upon all of the Grantor’s right, title and interest to the Trademark Collateral, including without limitation, the trademarks listed on Exhibit A hereto (collectively, the “Intellectual Property Collateral”); and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on May 9, 2017 at Reel/Frame 6053/0318.

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement, the Agent hereby (i) releases any and all continuing security interest and continuing lien upon, and terminates and cancels any and all of its security interest in, and all other rights, title and interest in and to, the Intellectual Property Collateral, without any recourse, representation or warranty, (ii) re-assigns to Grantor, any right, title or interest the Agent may have in, to or under the Intellectual Property Collateral, together with the goodwill of the business symbolized thereby, and hereby authorizes Grantor or their authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination, and (iii) agrees to timely cooperate with and to timely take all reasonable actions and to provide to Grantor, its successors, assigns, or other legal representatives with all such cooperation and assistance (including, without limitation, the execution and delivery of any and all other documents or other instruments) and to take any further action, in each case at Grantor’s sole expense, which is reasonably requested by any Grantor and is necessary to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
