RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Agreement") dated as of this 21st day of August, 2020, is made by and among The Bank of Tampa, a Florida Banking Corporation, 601 Bayshore Boulevard, Suite 830, Tampa, Florida 33606 (the "Assignor"), and Reliaquest, LLC, a Florida Limited Liability Company, Suite 500, 777 S. Harbour Island Blvd., Tampa Florida 33602 (the "Assignee"). Unless otherwise defined herein, or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided (or incorporated by reference) in the Security Agreement (as defined below).

WHEREAS, Assignees are the record owners of the trademarks listed on Schedule A to this Agreement ("Trademark Collateral");

WHEREAS, pursuant to the Security Agreement ("Security Agreement"), among the Assignor and the Assignee, the Assignee mortgaged, pledged, hypothecated and granted to the Assignor a security interest in, for the Assignor's benefit Assignee's right, title and interest in the Trademark Collateral owned or held by the Assignee;

WHEREAS, the Security Agreement was executed on July 20, 2017 and recorded in the U.S. Trademark and Trademark Office on August 4, 2017 at Reel/Frame 6123/0173;

WHEREAS, the Assignor has terminated and released its liens and security interests on Assignee's Trademark Collateral; and

NOW, THEREFORE, in consideration for the satisfaction of the security interest, and for other good and valuable consideration, the receipt of which is hereby acknowledged:



Effective August 21, 2020, Assignor hereby releases any and all right, title and interest in all the Trademark Collateral owned or held by the Assignee, including, but not limited to, the right to sue for past, present and future infringement or dilution thereof or for any injury to goodwill, and the proceeds thereof, and hereby reassigns such right, title and interest in such Trademark Collateral to the Assignee.

2. This Agreement may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same instrument.
