RELEASE OF SECURITY INTEREST IN TRADEMARKS

November 28, 2018

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "**Release**") dated as of November 28, 2018, is made by **SUNTRUST BANK**, a Georgia banking corporation (together with its successors and assigns, the "**Assignor**"), with a mailing address at 3333 Peachtree Road, 4th Floor, East Tower, Atlanta, Georgia 30326, in favor of **CITIZENS LANIER HOLDINGS, LLC**, a Delaware limited liability company, having a mailing address at 405 Lexington Avenue, Suite 500, New York, NY 10174 ("**Parent**"), **LANIER PARKING HOLDINGS, INC.**, a Georgia corporation having a mailing address at 2600 Harris Tower, 233 Peachtree Street, NE, Atlanta, Georgia 30303 ("**Lanier**"), and certain of their Subsidiaries from time to time a party to the Intellectual Property Security Agreement (such Subsidiaries, together with Parent and Lanier, collectively, the "**Assignees**" and each an "**Assignee**"). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Intellectual Property Security Agreement or the Security Agreement, as applicable.

WHEREAS, pursuant to that certain security agreement, dated as of January 29, 2016, in favor of the Assignor (including all annexes, exhibits and schedules thereto, and as from time to time may have been amended, restated, supplemented or otherwise modified, the "**Security Agreement**"), each Assignee granted to Assignor, for itself and for the benefit of the Bank Product Providers, a continuing security interest in and to the Collateral, including the Trademarks listed on Schedule A attached hereto.


WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of January 29, 2016, made by Assignees in favor of Assignor, as recorded with the United States Patent and Trademark Office on February 1, 2016, at Reel 5721 Frame 0399, each Assignee granted to and in favor of Assignor, for its benefit and for the benefit of each of the Bank Product Providers, a perfected security interest and lien in and to (together with the security interest granted under the Security Agreement, the "**Interest**") any and all of such Assignee's right, title and interest in and to any and all Intellectual Property (including any Trademarks) then-owned and existing and thereafter arising, created or acquired, including the Trademarks listed on Schedule A attached hereto (collectively, the "**Released Trademarks**").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby (i) terminate, release and forever discharge its Interest in and to the Released Trademarks, (ii) terminate the Intellectual Property Security Agreement, and (iii) reassign to Assignees any right, title or interest of Assignor in or to the Released Trademarks and all goodwill associated therewith. The Assignor authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release. This Release shall be governed by, enforced and construed in accordance with the internal laws of the State of New York, without regard to choice of law or conflict of law principles. A signature hereto sent or delivered by facsimile or other electronic transmission shall be as legally binding and enforceable as a signed original for all purposes.
