

The Assignor hereby authorizes and requests the Commissioner for Trademarks of the United States to issue, record, and memorialize this Assignment with regard to all of the Marks.

Assignor further covenants that it will execute documents, papers, forms, and authorizations and take other reasonable actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Marks. Assignee is responsible for all procedural aspects of sale, assignment, transfer and conveyance of the Marks and assumes all costs, other than Assignor's in-house costs, associated with the preparation, filing of all documents, papers, forms, and authorizations necessary to record and memorialize this Agreement.

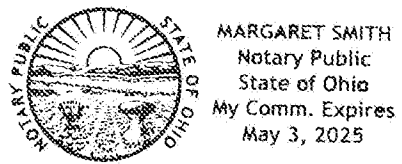
