NOW, THEREFORE, to the extent that any ITU IP is registered with the United States Patent and Trademark Office or any other government body or regulatory agency, Assignor shall promptly assign, sell and transfer unto Assignee all right, title and interest in and to such ITU IP along with all Goodwill associated therewith;


NOW, THEREFORE, Assignor shall execute any and all other documents requested by Assignee in order to effect the terms and intent of this Assignment.
