TRADEMARK ASSIGNMENT

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby assigns and transfers exclusively to ASSIGNEE, in perpetuity and throughout the world, all of ASSIGNOR's rights, title, and interest in and to the Marks, including: (i) all goodwill of the business symbolized by or associated with the Marks; (ii) all existing trademark and service mark registrations and applications (if any) for the Marks as identified in Exhibit A hereto and all extensions and renewals thereof; (iii) the right to sue and make claims and recover damages for any past, present or future infringement, misappropriation or unauthorized use of the Marks; (iv) the right to all incomes, license fees, royalties, proceeds and other payments that are now or may hereafter become due or payable with respect to the Marks; and (v) all other statutory and common law rights in and to the Marks that may exist now or in the future under the laws of the United States (federal or state) and any foreign country; all such rights, title, and interest to be held and enjoyed by ASSIGNEE and its successors and assigns, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR had this Assignment not been made.

ASSIGNEE will be entitled to record this Assignment with the United States Patent and Trademark Office, and ASSIGNOR will provide reasonable assistance to ASSIGNEE in this regard.

This Assignment shall be governed by and construed in accordance with the federal trademark law of the United States and the laws of the State of Delaware (to the extent not conflicting with the federal trademark law of the United States).




