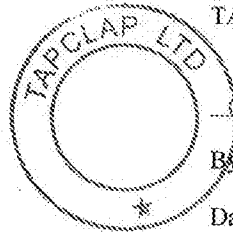
The U.S. Trademark ARTNUM (US Registration No. 5955175).
