GRANT OF SECURITY INTEREST

THIS GRANT OF SECURITY INTEREST, dated as of August 26, 2020, is executed by TRUWEO, LLC, a Delaware limited liability company with an address of 37 East 18th St., 7th Floor, New York, NY 10003 (“Debtor”), in favor of HORIZON TECHNOLOGY FINANCE CORPORATION, a Delaware corporation with an address of 312 Farmington Avenue, Farmington, Connecticut 06032, as collateral agent (“Secured Party”).

A. Pursuant to a certain Venture Loan and Security Agreement, dated as of December 31, 2018 (the “Agreement”) by and among Debtor, the Secured Party and the other parties thereto, the Secured Party extended certain credit facilities to Mohawk Group Holdings, Inc., a Delaware corporation (“Mohawk Holdco”), Mohawk Group, Inc., a Delaware corporation (“Mohawk”) and the other debtor parties thereto, upon the terms and subject to the conditions set forth therein;

B. On or about the date hereof, pursuant to a certain Omnibus Limited Consent, Joinder and Amendment to Venture Loan and Security Agreement, Debtor became a party to the Agreement;

C. Debtor owns the registered patents, trademarks, service marks (and applications and registrations therefor), of the United States, more particularly described on Schedules 1-A and 1-B annexed hereto as part hereof (collectively, the “Intellectual Property”);


D. Pursuant to the Agreement, Debtor has granted to Secured Party a security interest in all right, title and interest of Debtor in and to the Intellectual Property, together with associated goodwill, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof for the full term of the Intellectual Property (the “Collateral”), to secure the prompt payment, performance and observance of the Obligations (as defined in the Agreement);

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby further grant to Secured Party a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Collateral granted hereby are more fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
