CERTIFICATE OF INCORPORATION

OF

BIRCH RUN INC.

(Under Section 807 of the Business Corporation Law)

1. The name of the corporation is Birch Run Inc. (the "Corporation"). The name under which the Corporation was originally formed is Polymer Conversions, Inc.
2. The original Certificate of Incorporation was filed in the office of the Secretary of State of New York on December 7, 1978 (as amended or restated, the "Certificate of Incorporation").
3. The text of the Certificate of Incorporation is hereby amended to change the name of the corporation, amend the corporation's business purpose, change the address for service of process and delete paragraph 6 related to the corporation's initial accounting period in its entirety.
4. To accomplish the foregoing amendments, the certificate of incorporation is amended and restated as follows:
 - (1) The name of the corporation is Polymer Conversions Holdings, Inc.
 - (2) The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the BCL, provided that it is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body without such consent or approval first being obtained.
 - (3) The office of the Corporation is to be located in the Town of Orchard Park, County of Erie, State of New York.
 - (4) The aggregate number of shares which the Corporation shall have the authority to issue is two hundred (200) shares, all of which are to be without par value.
 - (5) The Secretary of State of the State of New York is designated as agent of the Corporation on whom process against the Corporation may be served. The Secretary of State shall mail a copy of any process against the

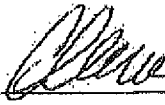
Corporation served on him or her to Corporation Service Company located at 80 State Street, Albany, New York 12207-2543.
