**TERMINATION AND RELEASE  
OF TRADEMARK SECURITY AGREEMENT**

**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Release"), dated as of August 31, 2020, by **AUDAX PRIVATE DEBT LLC**, in its capacity as collateral agent (the "Collateral Agent"), in favor of **BACKSTAGE, LLC**, a Delaware limited liability company and **Sonicbids LLC**, a Delaware limited liability company (the "Pledgors").

**WHEREAS**, pursuant to the terms of that certain Trademark Security Agreement, dated as of October 19, 2018 (the "Trademark Security Agreement"), by the Pledgors in favor of the Collateral Agent, the Pledgors granted to the Collateral Agent a security interest in and to the following property of the Pledgors, now owned or hereafter acquired by the Pledgors (collectively, the "Collateral"):

- (a) trademarks and registrations thereof, including the trademarks listed on Schedule 1 (collectively, the "Trademarks");
- (b) the goodwill of the business symbolized by the Trademarks; and
- (c) all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof.

**WHEREAS**, the Collateral Agent wishes to terminate and release its security interests in and to all of the right, title and interest of the Pledgors in and to the Collateral, and to release its liens on the Collateral; and


**WHEREAS**, the Trademark Security Agreement was filed on October 22, 2018 with the United States Patent and Trademark Office in Reel: 6462; Frame: 0430.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and discharges fully its security interests in and to all of the right, title and interest of the Pledgors in and to the Collateral, releases its liens on the Collateral as granted under the Trademark Security Agreement, and reassigns and transfers to the Pledgors all right, title and interest that the Collateral Agent may have in the Collateral, and terminates the Trademark Security Agreement. The Collateral Agent hereby authorizes the Pledgors, or the Pledgors' authorized representative or designee, to record this Release with the United States Patent and Trademark Office.
