## RELEASE OF SECURITY INTEREST - TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "**Release**"), dated as of August 25, 2020, is made by ZIONS BANCORPORATION, N.A. dba National Bank of Arizona, successor by merger to National Bank of Arizona ("**Lender**"), whose address is 6001 N. 24<sup>th</sup> Street, Phoenix, Arizona 85016, in favor of HARLEM GLOBETROTTERS INTERNATIONAL, INC., a Nevada corporation, whose address is 5445 Triangle Parkway, Suite 200, Peachtree Corners, Georgia 30092 ("**Grantor**").

WHEREAS, reference is hereby made to (i) that certain Loan and Security Agreement dated December 26, 2013 (the "**Security Agreement**"), executed by Grantor and (ii) that certain Grant of a Security Interest - Trademarks dated December 23, 2013, executed by Grantor in favor of Lender and recorded on December 30, 2013 in the United States Patent and Trademark Office at Reel 5183, Frame 0313 (the "**Trademark Security Agreement**"); and

WHEREAS, pursuant to the Trademark Security Agreement, to secure the prompt payment, performance and observance of the secured Obligations (as defined in the Security Agreement), Grantor granted to Lender a continuing security interest in all of the Grantor's right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement), including those trademarks and service marks listed on the attached Schedule A; and

WHEREAS, the secured Obligations have been paid in full and Lender wishes to release Lender's security interest in and to the Collateral, and retransfer and reassign to Grantor all of Lender's right, title and interest in and to the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender agrees as follows:

**SECTION 1.**           Defined Terms. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Security Agreement.

**SECTION 2.**           Termination and Release. Lender hereby terminates the Trademark Security Agreement, and releases and discharges fully, without representation, warranty or recourse of any kind, its continuing security interest in the Collateral, including the trademarks listed on Schedule A attached hereto, and reassigns and transfers to the Grantor all right, title and interest that Lender may have in the Collateral.

**SECTION 3.**           Recordation. Lender hereby authorizes the Grantor, or the Grantor's authorized representative, to record this Release with the United States Patent and Trademark Office.

**SECTION 4.**           Further Assurances. Lender hereby agrees to duly execute and deliver to the Grantor any further documents and to do such other acts that the Grantor (or its agents or designees) reasonably requests, at the Grantor's sole cost and expense, in order to confirm this Release.

**SECTION 5.**            Governing Law.    THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF ARIZONA.
