**NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARK**

This RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Release") dated as of August 11 2020, is made by Rosenthal & Rosenthal, Inc. ("Rosenthal") in favor of Domaine Wine & Spirits, LLC (the "Company").

WHEREAS, the Company and Rosenthal entered into a Security Interest dated May 9, 2018, which was recorded with the United States Patent and Trademark Office (the "USPTO") on 5/11/2018, at Reel/Frame 6386/0304 (the "Security Interest");

WHEREAS, pursuant to the Security Interest, Rosenthal received security interests in all of the Company's rights, titles and interests in and to certain trademarks, including the trademark registration and application for the trademark registration set forth on Schedule A hereto (such trademark on Schedule A, the "Trademark");

WHEREAS the Company has requested and Rosenthal agrees to release any and all security interests, and any other lien, it has in the Trademark, and assign all right, title and interest it may have in and to the Trademark to Company.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Rosenthal hereby agrees as follows:


1. Defined terms. All capitalized terms used, but not otherwise defined herein, shall have the meaning ascribed in or otherwise referenced in the Security Interest.
2. Release. Rosenthal hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark. If and to the extent that Rosenthal has acquired any right, title or interest in and to the Trademark, Rosenthal hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Company, without any recourse, representation or warranty of any kind. This release is limited only to the Trademark, and not to any other trademarks of the Company assigned nor or hereafter to Rosenthal.
3. Termination. Rosenthal acknowledges and agrees that the Security Interest has been terminated.
4. Authorization. Rosenthal hereby authorizes the Company or the Company's agent to record this Notice of Release Security Interest in Trademark with the United States Patent and Trademark Office and any foreign trademark office as required.
5. Further Assurances. Rosenthal agrees to take all further actions, and provide to the Company and its successors, assigns or other legal representative, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonable requested by the Company, at the Company's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

6. Governing Law. This release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
