RELEASE OF TRADEMARK SECURITY INTEREST

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Release of Security Interest. Agent hereby releases, terminates, cancels, relinquishes and discharges any security interest it may have in, and any right of set off against, the trademarks listed in Appendix 1 hereto, including any goodwill of the business symbolized by the foregoing, and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Grantor.

2. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a signed counterpart of this Release.

3. Further Assurances. Agent hereby agrees to, at the sole cost and expense of Grantor, take all further actions, and provide to Grantor its cooperation and assistance (including, without limitation, the execution, acknowledgement, procurement, and delivery of any further documents) and to do such other acts as may be reasonably requested by Grantor to effect the termination and release of the security interest contemplated hereby.

4. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law provisions.
