(the "**Pledgor**")

and

**Barclays Bank PLC**, a financial institution constituted and existing under the laws of England and Wales, registered no: 1026167 with its registered office at 1 Churchill Place, London, E14 5HP, United Kingdom, acting for itself and as agent in the name and on behalf of the other Secured Parties (as defined below) as direct representative

(the "**Collateral Agent**")

## Recitals

### WHEREAS:

- A) The Pledgor is party to an existing credit agreement dated 14 August 2019 (as amended, modified or supplemented from time to time, the "**Existing Credit Agreement**") between, inter alios, Swissport Holding International S.à r.l. ("**Holdings**"), Swissport Financing S.à r.l. (the "**Lux Borrower**"), Swissport International AG (the "**Revolving Borrower**" and together with the Lux Borrower, each a "**Borrower**" and, collectively, the "**Borrowers**"), Barclays Bank PLC as agent (the "**Administrative Agent**"), Barclays Bank PLC as the collateral agent (the "**Collateral Agent**"), Barclays Bank PLC as sole and exclusive Arranger and Bookrunner (each as defined therein) and certain financial institutions as lenders, pursuant to which the lenders have agreed to make available term credit facilities and a revolving credit facility.
- B) Under an indenture dated 14 August 2019 between, inter alios, Swissport Financing S.à r.l. as issuer (the "**Issuer**"), Holdings as parent guarantor, U.S. Bank Trustees Limited as notes trustee, Elavon Financial Services DAC as principal paying agent and the Collateral Agent (as amended, modified or supplemented from time to time), the Issuer has issued EUR 410,000,000 5.25% senior secured notes due 2024.
- C) The Pledgor is currently also party to a number of existing security documents, including in particular an Existing Trademark Pledge Agreement (as defined below).
- D) Furthermore, on 14 August 2019, some of the parties to the Existing Credit Agreement, amongst others, have entered into an intercreditor agreement (as amended, supplemented or otherwise modified prior to Intercreditor Amendment, as defined below, the "**Existing Intercreditor Agreement**"), which was amended by an amendment No. 1 to intercreditor agreement dated 6 July 2020 entered into between, among others, Holdings and the Administrative Agent (the "**Intercreditor Amendment**", and the Existing Intercreditor Agreement as amended, supplemented or otherwise by the Intercreditor Amendment, the "**Intercreditor Agreement**").
- E) Pursuant to a super senior facilities agreement dated on or about 28 August 2020 (as amended, modified or supplemented from time to time, the "**Super Senior Facilities Agreement**") made between, inter alios, Holdings, Swissport Financing S.à r.l. as Lux Borrower, Global Loan Agency Services Limited as administrative agent, the Collateral Agent, and certain financial institutions as lenders (the "**Lenders**"), the Lenders have agreed to make available super senior facilities.
- F) It is a condition under the Super Senior Facilities Agreement that the Pledgor enters into this Agreement (as defined below) to secure all claims of the Secured Parties (as defined below) under the Secured Documents (as defined below) by way of a pledge over the



Trademarks (as defined below) in addition to the pledge already granted under the Existing Trademark Pledge Agreement (as defined below).

NOW, THEREFORE, the Pledgor, the Secured Parties and the Collateral Agent (each individually a "**Party**" and together the "**Parties**") agree as follows.

## **1 Definitions and Interpretation**

1.1 Unless the context otherwise requires, terms defined in the Intercreditor Agreement which are not otherwise defined in this clause 1.1 have the meaning given to them in the Intercreditor Agreement.

Acceleration Event means the occurrence of a Senior Secured Facilities Event of Default, a Senior Secured Notes Event of Default, a Pari Passu Debt Event of Default, or a Super Senior Secured Debt Event of Default, which is continuing.

Agreement means this trademark pledge agreement.

CC means the Swiss Civil Code, as amended from time to time.

DEBA means the Swiss Federal Debt Enforcement and Bankruptcy Act, as amended from time to time.

Debtors means each person being party to the Intercreditor Agreement in the capacity as "Debtor" on the date hereof and any person which becomes a party to the Intercreditor Agreement as a "Debtor" in accordance with the terms of the Intercreditor Agreement.

Existing Trademarks means the trademarks and trademark applications listed in Schedule 1.

Existing Trademark Pledge Agreement means the trademark pledge agreement dated 14 August 2019 entered into between the Pledgor and the Collateral Agent over the Secured Assets.

Future Trademarks means any and all non-registered trademarks, trademark applications and trademarks which the Pledgor will in the future respectively file, register and/or otherwise acquire.

including when introducing an example, does not limit the meaning of

the words to which the example relates to that example or examples of a similar kind.

Secured Assets	means any and all of the Trademarks from time to time subject, or expressed to be subject, to the Security Interest.
Senior Secured Obligations	means the Senior Secured Debt Obligations and the Super Senior Secured Debt Obligations.
Security Interest	means all or any of the security created or expressed to be created by or pursuant to clause 2 of this Agreement.
Secured Documents	means the Senior Secured Documents and the Super Senior Secured Debt Documents.
Secured Parties	means the Collateral Agent, any Receiver or Delegate, the Senior Secured Parties and the Super Senior Secured Creditors.
Trademarks	means the Existing Trademarks and/or the Future Trademarks together with all rights, claims or benefits pertaining thereto, to the extent such rights, claims or benefits are assignable.

1.2 This Agreement is subject to the provisions of the Intercreditor Agreement. The Collateral Agent shall hold and administer the security created under this Agreement for the benefit of the Secured Parties subject to the terms of the Intercreditor Agreement. In the event of any inconsistency between this Agreement and the Intercreditor Agreement, the Intercreditor Agreement shall prevail.

1.3 In this Agreement, unless otherwise provided, a reference to (i) a provision of law is a reference to that provision as amended or re-enacted, (ii) a clause or a schedule is a reference to a clause or a schedule of this Agreement, (iii) a person includes its successors, assigns and transferees and (iv) any agreement or document is a reference to that agreement or document as amended, novated, supplemented, restated or replaced.

1.4 The headings in this Agreement are for convenience only and are to be ignored in the interpretation of this Agreement.

## **2 Pledge**

2.1 As security for the due and punctual performance and discharge of the Senior Secured

Obligations, the Pledgor hereby pledges all Existing Trademarks, and agrees to pledge any Future Trademarks, to the Collateral Agent, acting for itself and as agent in the name and on behalf of the other Secured Parties (as direct representative).

- 2.2 The Pledgor and the Collateral Agent (acting for itself and as agent in the name and on behalf of the secured parties under the Existing Trademark Pledge Agreement and under this Agreement as direct representative) agree that the Security Interest created or expressed to be created pursuant to this Agreement shall have equal rank with the Existing Trademark Pledge Agreement.
- 2.3 For the avoidance of doubt, the Parties agree that nothing in this Agreement shall be construed as a release of, or amendment to, any provision of the Existing Trademark Pledge Agreement and that the security interest created thereunder shall remain in full force and effect and shall continue to secure the "Senior Secured Obligations" as defined therein.
- 2.4 In order to perfect the Security Interest in accordance with article 903 CC, the Pledgor hereby notifies the Collateral Agent (acting for itself and as agent in the name and on behalf of the secured parties under the Existing Trademark Pledge Agreement as direct representative) of the Security Interest created or expressed to be created hereunder.
- 2.5 With respect to the Security Interest granted hereunder, the Pledgor confirms that the current registration of a Security Interest over Trademarks in the applicable trademarks registers covers both (i) the Security Interests created pursuant to this Agreement and (ii) the security interest created pursuant to the Existing Trademark Pledge Agreement. For the avoidance of doubt, the Security Interest granted hereunder will not be registered in any trademarks registers (i) insofar the Trademarks already registered under the Existing Trademark Pledge Agreement remain registered as a collateral for the benefit of the Collateral Agent and (ii) with regard to any Trademarks for which no registration was made pursuant to the terms and conditions of the Existing Trademark Pledge Agreement.
- 2.6 With respect to Future Trademarks, the Pledgor shall promptly perform all measures and acts and execute and deliver all written instruments and declarations required in order to give full effect to or complete the Security Interest in the various jurisdictions in which Trademarks applications of the Pledgor are pending or will be filed and/or in which Trademarks are or will be registered, including to effect the registration of the Collateral Agent as pledgee of the Trademarks in the trademark registers of those jurisdictions in which such registration is legally required in order to enable the Collateral Agent to exercise and enforce all its rights under this Agreement, whereby the Security Interests granted hereunder will only be registered with regard to material Trademarks and only to the extent such registration is legally necessary for the perfection of the Security Interest. The costs incurred in connection with such

measures, written instruments or declarations, including the fees for the registration of the Collateral Agent as pledgee of the Trademarks in any trademark register shall be exclusively borne by the Pledgor.

2.7 The Security Interest granted hereunder shall always be subject to the Security Principles.

### **3 Representations and Warranties**

3.1 On the date of this Agreement, the Pledgor represents and warrants to the Collateral Agent that:

3.1.1 it is the sole owner of each of the Existing Trademarks, free from any Liens and third party right, other than under the Existing Trademark Pledge Agreement, and subject to any Permitted Liens (as defined in the Secured Documents);

3.1.2 each of the Existing Trademarks is (where applicable) properly registered in its name and it has the unlimited ability to grant a pledge over each of the Existing Trademarks free from any Liens and third party right, other than under the Existing Trademark Pledge Agreement, and other than any Permitted Liens (as defined in the Secured Documents).

### **4 Undertakings**

4.1 To the extent not already delivered under the Existing Trademark Pledge Agreement, the Pledgor undertakes to the Collateral Agent that during the term of this Agreement it shall provide to the Collateral Agent every year upon request of the Collateral Agent (starting one year from the date of this Agreement) an update of Schedule 1.

### **5 Continuing Security**

5.1 The security constituted by this Agreement shall be a continuing security, shall extend to the ultimate balance of the Senior Secured Obligations and shall continue in force notwithstanding any intermediate payment of the Senior Secured Obligations.

5.2 The Collateral Agent shall not be obliged to make any claim or demand on the Pledgor or to resort to any other Transaction Security granted under or in connection with the Secured Documents or other means of payment now or hereafter held by or available to it before enforcing the Security Interest and no action taken or omitted by the Collateral Agent in connection with any such claim, demand, security or other means of payment shall discharge, reduce, prejudice or affect the liability of the Pledgor under this Agreement. For the avoidance of doubt, the Security Interest is independent from

any other security under the Secured Documents (including the Existing Trademark Pledge Agreement) and the Collateral Agent shall not be required to enforce first any other such security.

- 5.3 The rights and remedies provided in this Agreement are cumulative and not exclusive of any rights and remedies provided by applicable law.

## **6 Enforcement**

- 6.1 Following the occurrence of an Acceleration Event, the Collateral Agent shall have the right to enforce the Security Interest either through enforcement proceedings or, after having given three (3) Business Days notice thereof to the Pledgor, by way of a private sale of the Secured Assets (including, to the extent legally permissible, by way of Selbsteintritt). The Collateral Agent shall enjoy full discretion to the extent legally permissible as to the manner, time and place of enforcement of the Security Interest under this Agreement.

- 6.2 The Collateral Agent shall be at liberty, notwithstanding the foregoing and the provisions of article 41 DEBA, to institute and pursue ordinary enforcement proceedings for the recovery of debt without having first to dispose of, or to institute enforcement proceedings for the realisation of, the Secured Assets.

- 6.3 Any proceeds realised and received by the Collateral Agent shall be applied to the payment of the Senior Secured Obligations in accordance with the terms of the Intercreditor Agreement.

- 6.4 The Collateral Agent shall not be liable for any losses arising out of the enforcement of this Agreement, except in case of wilful misconduct or gross negligence.

- 6.5 The obligations and undertakings of the Pledgor under this Agreement, and the scope of the Security Interest, shall be subject to the limitations set out in Section 8.12 (d) of the Super Senior Facilities Agreement and Section 8.12 (d) of the Existing Credit Agreement, if and to the extent that these limitations are applicable.

## **7 Power of Attorney**

- 7.1 The Pledgor hereby appoints the Collateral Agent, with the right of substitution, to be its attorney and to act in its name and on its behalf (i) upon or after an Acceleration Event or (ii) if the Pledgor has failed to comply with a further assurance or perfection obligation within ten (10) Business Days of the earlier of awareness and receiving notice of that failure and being requested to comply, and in such manner as the attorney thinks fit:

- 7.1.1 in case of 7.1 (i) above, to do anything which the Pledgor is obliged to do (but has not done) under any Secured Document to which it is a party (including to execute charges over, transfers, conveyances, assignments and assurances of, and other instruments, notices, orders and directions relating to the Secured Assets); and
- 7.1.2 in case of 7.1 (ii) above, to take any such action to perfect the Security Interest or comply with any relevant obligation.
- 7.2 The Pledgor hereby undertakes not to revoke such power of attorney and, if required and upon request from the Collateral Agent, to promptly renew such power of attorney and in any event to ratify and confirm all things done by the attorney in connection and in accordance with this Agreement.

## 8 **Miscellaneous**

### 8.1 Confirmation

In the performance of the Collateral Agent's role under this Agreement, the Collateral Agent shall have the protections, immunities, rights, powers, authorisations, indemnities and benefits (*mutatis mutandis*) as are conferred upon the Collateral Agent in the Intercreditor Agreement. The rights, powers and remedies herein provided are cumulative and not exclusive of any rights, powers or remedies provided in the Intercreditor Agreement.

### 8.2 Assignment

8.2.1 The Pledgor may not assign or transfer, in whole or in part, any of its rights and obligations under this Agreement without the prior written consent of the Collateral Agent.

8.2.2 The Collateral Agent shall be entitled to assign and transfer its rights and obligations under this Agreement, and to assign the Secured Assets, to any person replacing it as collateral agent in accordance with the terms of the Secured Documents. The Pledgor shall upon request by the Collateral Agent take all measures and do all acts necessary or useful to effect such assignment, transfer and delivery at its own costs.

8.2.3 In the event that rights and obligations of the Secured Parties are transferred in accordance with the terms of the Secured Documents, the Security Interest shall extend to, and secure, any new Senior Secured Obligations arising as a result of such transfer.

### 8.3 No Waiver

No failure or delay on the part of the Collateral Agent to exercise any power, right or

remedy under this Agreement shall operate as a waiver thereof, nor shall any single or partial exercise by the Collateral Agent of any power, right or remedy preclude any other or further exercise thereof or the exercise of any other power, right or remedy.

8.4 Severability

If, at any time, any provision of this Agreement is or becomes illegal, invalid or unenforceable in any respect under any law of any jurisdiction, neither the legality, validity or enforceability of the remaining provisions nor the legality, validity or enforceability of such provision under the law of any other jurisdiction will in any way be affected or impaired. The Parties shall use their reasonable endeavours to reach an agreement to have the invalid provision replaced by a valid arrangement coming as close as possible to the purpose of the invalid provision and to the intention of the Parties related to such provision.

8.5 Amendments

Any amendment or waiver of this Agreement or any provision of this Agreement shall only be binding if agreed in writing by the Parties.

8.6 Counterparts

This Agreement may be executed in separate counterparts each of which, when executed and delivered, shall constitute an original, and all of which together shall constitute one and the same instrument.

8.7 Jurisdiction

Any suit, claim, action or proceeding arising out of or in connection with this Agreement and the transactions contemplated by it shall be brought before the Courts of the City of Zurich, Switzerland. Nothing in this clause shall limit the right of the Collateral Agent to bring any suit, claim, action or proceeding in any other court of competent jurisdiction in or outside Switzerland.

8.8 Applicable law

This Agreement and the Security Interest (including as to matters of its creation and perfection) shall be governed by substantive Swiss law, to the exclusion of conflicts of law provisions.
