IP COLLATERAL RELEASE AND REASSIGNMENT

THIS IP COLLATERAL RELEASE AND REASSIGNMENT is made as of September 1, 2020, by Crestline Direct Finance, L.P. (“Grantee”).

W I T N E S S E T H:

WHEREAS, Prospira Paincare, Inc., a Delaware corporation (“Grantor”) and Grantee were parties to that certain Intellectual Property Security Agreement dated as of April 5, 2018 (the “Security Agreement”; capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Security Agreement), in each case, pursuant to which Grantor granted a lien on and security interest in certain IP Collateral (as defined in the Security Agreement) as security for certain obligations owing by Grantor to Grantee, including, without limitation, the trademarks and domain names set forth on Schedule A hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on April 5, 2018, at Reel 6308 and Frame 0441;

WHEREAS, Grantor has requested that Grantee release its lien on and security interest in the IP Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in all of Grantor’s right, title and interest in and to the IP Collateral, including, without limitation, the trademarks and domain names set forth on Schedule A hereto.
2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, any and all of Grantee’s right, title and interest in and to the IP Collateral.
