## DECLARATION OF ANDREA L. RITCHEY

1. My name is Andrea L. Ritchey, and I am the Director of Marketing at McLanahan Corporation. I hereby make this Declaration based on my first hand knowledge of the facts.

2. LPT Group, Inc., which was owned by McLanahan Corporation, was assigned U.S. Trademark Reg. No. 1,196,667 for HYDROSIZER by Linatex Corporation of America by way of a written assignment agreement. That assignment agreement was recorded with the U.S. Patent and Trademark Office on March 9, 1981 at Reel 2360, Frame 0302.

3. Thereafter, LPT Group, Inc. was dissolved and the HYDROSIZER registration reverted to incorporator, McLanahan Corporation. That dissolution and transfer was recorded with the U.S. Patent and Trademark Office on February 21, 2012 at Reel 4720, Frame 0553.

4. It has recently come to the attention of McLanahan Corporation that on or about May 7, 2015, a document was recorded with the U.S. Patent and Trademark Office at Reel 5511, Frame 0823 that purported to transfer ownership of the HYDROZISER registration from Linatex Corporation of America to Linatex Corporation of America, LLC.

5. As evidenced by the recorded assignment to LPT Group, Inc. detailed in paragraph 2 above and the subsequent reversion to McLanahan Corporation detailed in paragraph 3 above, Linatex Corporation of America did not have any interest in and to the HYDROSIZER registration to transfer in 2015, and thus this filing was ineffective and should be expunged as an erroneous and ineffectual transfer of interests.

6. The correct owner of the HYDROSIZER registration is McLanahan Corporation,  
200 Wall Street, Hollidaysburg, PA 16648.
