OPEN TEXT HOLDINGS, INC.

(Pursuant to Section 253 of the General Corporation Law of Delaware)

Open Text Holdings, Inc., a corporation incorporated on June 27, 2012 (the "Corporation"), pursuant to the provisions of the General Corporation Law of the State of Delaware (the "DGCL");

DOES HEREBY CERTIFY that this corporation owns 100% of the capital stock of Guidance Software, Inc., a corporation incorporated on November 17, 2006 pursuant to the provisions of the DGCL, and that this Corporation, by a resolution of its Board of Directors duly adopted by unanimous written consent on June 26, 2018, determined to and did merge said Guidance Software, Inc. with and into itself, with this Corporation being the surviving entity of such merger, which resolution is substantially in the following words to wit:

WHEREAS, the Corporation lawfully owns 100% of the outstanding stock of Guidance Software, Inc., a corporation organized and existing under the laws of the State of Delaware ("Guidance");

WHEREAS, the Corporation desires to merge into itself Guidance (the "Merger"), with the Corporation being the surviving entity of the Merger, and to be possessed of all the estate, property, rights, privileges and franchises of said corporation;

WHEREAS, the Corporation desires that the Merger be effective as of 3:05 a.m. Eastern Daylight Time on July 1, 2018 (the "Effective Time"); and

WHEREAS, pursuant to the Agreement of Merger by and between the Corporation and Guidance, at the Effective Time, (i) each share of capital stock of the Corporation shall remain outstanding (all such shares of the Corporation constituting the "Corporation Shares"), and the sole holder of all outstanding shares of capital stock of the Corporation immediately prior to the completion of the Merger shall be the sole holder of the Corporation Shares; and (ii) at the

Effective Time, all outstanding shares of capital stock of Guidance shall be cancelled and retired without payment of any consideration therefor, except as provided in clause (i) above.

NOW, THEREFORE, BE IT RESOLVED, that the Corporation merge Guidance with and into the Corporation, and assume all of its liabilities and obligations effective as of the Effective Time;

FURTHER RESOLVED, that an authorized officer of this Corporation be and he/she is hereby directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolution to merge Guidance and assume its liabilities and obligations, and the date of adoption thereof, and to file the same in the office of the Secretary of State of Delaware, and a certified copy thereof in the office of the Recorder of Deeds of New Castle County; and

FURTHER RESOLVED, that the officers of this Corporation be and they hereby are authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in any way necessary or proper to effect the Merger.
