

Terms defined in the Security Agreement and not otherwise defined herein are used herein as defined in the Security Agreement;

WHEREAS, pursuant to the Specified Intellectual Property Security Agreements, the Grantor, by reference to the Security Agreement, reaffirmed its intent to grant a security interest to the Administrative Agent in the Grantor's registered or applied for intellectual property, including the trademarks, patents and copyrights listed in <u>Schedule I</u> hereto (collectively, the "<u>Released Collateral</u>"); and

WHEREAS, in accordance with the terms for release of collateral set forth in the Credit Agreement and the Security Agreement, the Administrative Agent now desires to terminate and release the entirety of its security interest in the Released Collateral.

NOW, THEREFORE, in consideration of the foregoing, and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth herein, the Administrative Agent hereby states as follows:

1. Release of Security Interest. The Administrative Agent, without representation or warranty of any kind, hereby (i) terminates, cancels, releases, and discharges, without recourse, representation, or warranty, any and all security interest it has in or to the Released Collateral, including under the Security Agreement and each of the Specified Intellectual Property Security Agreements, and (ii) reassigns, re-transfers, and re-conveys, without representation or warranty of any kind, any and all such right, title, and interest (if any) that the Administrative Agent may

have in the Released Collateral to the Grantor. Any right, title, or interest of the Administrative Agent in such Released Collateral shall hereby cease and become void.

- <u>2.</u> <u>Further Assurances.</u> The Administrative Agent hereby agrees to, at the sole cost and expense of the Grantor, take all further actions, and provide to the Grantor its cooperation and assistance (including, without limitation, the execution, acknowledgement, procurement, and delivery of any further documents) and to do such other acts as may be reasonably requested by the Grantor to effect the termination and release of the security interest contemplated hereby.
- 3. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law provisions.
