**TERMINATION AND RELEASE OF
SECOND LIEN SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (“Release”) is made as of September 4, 2020 by **MACQUARIE CAPITAL FUNDING LLC**, a Delaware limited liability company (“Collateral Agent”) in favor of **SCUF GAMING INTERNATIONAL LLC**, a Georgia limited liability company with an address at 3970 Johns Creek Court, Suite 325, Suwanee, Georgia 30024 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain Second Lien Intellectual Property Security Agreement dated February 14, 2020 (the “IP Security Agreement”) with Collateral Agent, notice of which was recorded at the United States Patent and Trademark Office on February 14, 2020 at Reel 6865, Frame 0284;

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the IP Security Agreement, a security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of its Trademarks, including those listed in **Schedule A** (collectively, the “IP Collateral”).

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such IP Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the Secured Parties in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the IP Collateral of the Grantor, including any and all of the goodwill of the business associated with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Grantor any interest in such IP Collateral.
