TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), is made and entered into as of September 4, 2020 (the "Effective Date"), by and between the entities listed on Schedule 1 hereto on the one hand (collectively, "Assignors") and SIJ, LLC, a Delaware limited liability company, on the other hand ("Assignee"). Capitalized terms used in this Assignment but not otherwise defined herein have the meanings ascribed thereto in the Purchase Agreement (as defined below).

RECITALS

WHEREAS, The McClatchy Company, certain of its subsidiaries, SIJ Holdings, LLC, and, solely for Sections 5.19 and 5.20 thereto, Chatham Asset Management, LLC and, solely for purposes of Section 8.3, Chatham Asset High Yield Master Fund, Ltd., are parties to that certain Asset Purchase Agreement dated as of July 24, 2020 (the "Purchase Agreement") and that certain Intellectual Property Assignment Agreement, dated as of even date herewith, pursuant to which the parties have agreed that all Assigned Trademarks will be owned by Assignee and assigned to Assignee hereunder;

WHEREAS, this Assignment is being executed to effect and record the assignment and sale from Assignors to Assignee of the Assigned Trademarks (as defined below).

NOW, THEREFORE, in consideration of the foregoing and the provisions set forth herein and in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignment of Assigned Trademarks.

Upon the terms and subject to the conditions set forth in the Purchase Agreement, effective as of the Closing, each Assignor hereby irrevocably and perpetually sells, assigns, transfers, conveys and delivers to Assignee, free and clear of all Encumbrances of any and every kind, nature and description, other than Permitted Post-Closing Encumbrances, all right, title and interest of such Assignor in, to and under the following (collectively, the "Assigned Trademarks"), along with the ongoing and existing business to which the Assigned Trademarks pertain as transferred pursuant to the Purchase Agreement:

- (a) all rights in the Trademarks set forth on Schedule 1 hereto and any other Trademarks owned by the Assignors;
- (b) all applications, registrations, renewals and extensions of any of the foregoing;
- (c) all goodwill appurtenant to any of the foregoing;

(d) all rights of any kind whatsoever of such Assignor accruing under any of the foregoing provided by applicable Law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(e) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing;

(f) all related rights of priority and protection of interests of any of the foregoing;

(g) any and all claims, warranties, credits, causes of action and rights of such Assignor, with respect to any of the foregoing, including in each case rights to set-off, indemnity, warranty, reimbursement, refunds, recoupment, damages specific performance or other equitable relief and all other rights of enforcement or recovery possessed by such Assignor from or against any third party regardless of whether or not such rights are currently exercisable or such claims have been asserted.

2. Miscellaneous.

(a) This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York applicable to contracts made and to be performed entirely in such state without regard to principles of conflicts or choice of laws or any other law that would make the laws of any other jurisdiction other than the State of New York applicable hereto.

(b) This Assignment may be executed in two or more counterparts, each of which shall be deemed to be an original but all of which shall constitute one and the same agreement.
