TRADEMARK ASSIGNMENT AGREEMENT
(the "Agreement")

THIS AGREEMENT is dated 28 MARCH 2019 (the "Effective Date")

THEREFORE, in consideration of the sum of one dollar (\$1.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the Assignor hereby sells, assigns and transfers to the Assignee, all of its rights, title and interest in and to the Trademarks in Canada, the United States and the European Community, including, but not limited to, (i) the Registrations, any other registration and application for the registration of the Trademarks, (ii) all the goodwill appertaining to the Trademarks and (iii) all causes of action, rights of recovery and claims for damages or other relief relating, referring or pertaining to the Trademarks, along with all income, royalties, damages or payments due or payable at or prior to the date hereof including claims for past or future infringement or misappropriation of the Trademarks.


This Assignment will be governed by the laws of the Province of Quebec, Canada, and the federal laws of Canada applicable therein, and the courts of the Province of Quebec will have the non-exclusive jurisdiction with respect to any matter arising out of or in respect of this Agreement.

This Agreement may be signed in counterparts, which together shall constitute one agreement. If this Agreement is signed in counterparts, no party shall be bound until both parties have duly executed, or caused to be duly executed, a counterpart of this Agreement. Either party may deliver this Agreement to the other by electronic transmission.


The Assignee hereby accepts the above assignment.
