Trademark Assignment

WHEREAS, Casa Vinicola Pietro Sartori S.P.A., a joint stock company organized under the laws of Italy, having an office and place of business at Via Casette 2; Negrar; I-37024 Verona, Italy (hereinafter referred to as the ASSIGNOR) is the owner of the trademark **SARTORI DI VERONA**, US Registration No. 2,775,200, registered October 21, 2003 and **SARTORI**, US Registration No. 2,785,969, registered November 25, 2003 (the "TRADEMARKS") and it is the ASSIGNOR's intention to assign and transfer to the ASSIGNEE all of its right, title, and interest in and to the TRADEMARKS;

WHEREAS, ASSIGNEE is desirous of recording its ownership of the entire right, title and interest to the TRADEMARKS at the U.S. Trademark Office;

WHEREAS, each Party is duly authorized and capable of entering into this Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, together with the goodwill of the business symbolized by the TRADEMARKS, ASSIGNOR does hereby assign, grant, transfer and otherwise convey to ASSIGNEE, its successors, and assigns, its entire right, title and interest in and to the TRADEMARKS, including but not limited to all of ASSIGNOR'S common law rights and registrations pertaining thereto, all rights to sue for past, present or future infringement, misappropriation, unfair competition, or other violation of the

foregoing, and all rights to recover damages or lost profits in connection therewith, as well as all of the goodwill of the business symbolized by the TRADEMARKS.

ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States, as well as any official of any countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the TRADEMARKS and title thereto as the property of ASSIGNEE, its successors and assigns, in accordance with the terms of this Agreement.
