**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of September 8, 2020 (the "Release"), is made by OBSIDIAN, LLC, a Delaware limited liability company, in its capacity as collateral agent for the Lender Group (together with its successors, "Collateral Agent"), in favor of TR INTERMEDIATE HOLDINGS, LLC, a Delaware limited liability company, WINCUP, INC., a Delaware corporation, NEW RADNOR MANAGEMENT, INC., a Delaware corporation, NEW WINCUP HOLDINGS, INC., a Delaware corporation, NEW WINCUP EUROPE DELAWARE, INC., a Delaware corporation, NEW RADNOR CHEMICAL CORPORATION, a Delaware corporation, NEW STYROCHEM EUROPE DELAWARE, INC., a Delaware corporation, and NEW STYROCHEM U.S., LTD., a Delaware corporation (collectively, jointly and severally, "Grantors" and each individually "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Security Agreement (as defined below) or the Credit Agreement.

**WITNESSETH**

WHEREAS, the Grantors and the Collateral Agent entered into that certain Security Agreement, dated as of November 29, 2006 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors executed that certain (i) Patent Security Agreement, dated as of November 29, 2006 (the "Patent Security Agreement") and recorded with the U.S. Patent and Trademark Office ("USPTO") on December 5, 2006 at Reel/Frame No. 18584/0192, (ii) Trademark Security Agreement, dated as of November 29, 2006 (the "Trademark Security Agreement") and recorded with the USPTO on December 5, 2006 at Reel/Frame No. 3438/0754, and (iii) Copyright Security Agreement, dated as of November 29, 2006 (the "Copyright Security Agreement" and collectively with the Patent Security Agreement and the Trademark Security Agreement, the "Intellectual Property Security Agreements") and recorded with the U.S. Copyright Office ("USCO") on December 11, 2006 at V3546 D218, pursuant to which the Grantors granted to Collateral Agent, for the benefit of the Term Loan B Secured Parties, a continuing security interest in all of their right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement), the Trademark Collateral (as defined in the Trademark Security Agreement), and the Copyright Collateral (as defined in the Copyright Security Agreement).

WHEREAS, pursuant to the Notice of Assignment of Security Interest in Intellectual Property, dated as of January 7, 2009 (the "Assignment") and recorded March 18, 2009 with the USPTO at Reel/Frame Nos. 22440/0261 and 3957/0742 and with the USCO at V3575 D043, Morgan Stanley & Co. Incorporated assigned to Obsidian, LLC, all of its right, title and interest under the Intellectual Property Security Agreements.

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in all right, title and interest in, to and under all of the Patent Collateral, Trademark Collateral, and Copyright Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Patent Collateral, Trademark Collateral, and Copyright Collateral, including the issued patents, patent applications, trademark registrations, trademark applications, and copyright registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Patent Collateral, Trademark Collateral, and Copyright Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and

assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Patent Collateral, Trademark Collateral, and Copyright Collateral under the Security Agreement, the Intellectual Property Security Agreements, and the Assignment.
