Under Section 805 of the Business Corporation Law

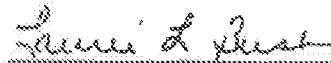
The undersigned, Lauris L. Bush, being the Vice President, Finance, of Thales Optem Inc., does hereby certify:
